As a trustee of the Naperville Education Foundation, I would like to welcome you back to Naperville Community Unit School District 203 for the 2003-2004 school year. I hope everyone had a rewarding summer.

Once again we would like to invite you to participate in *Cents for Kids*, the payroll deduction plan that contributes the extra cents in your paycheck to the Foundation Grant Fund. Last year we raised over \$9,200 for District 203 teachers' grants. Participating employees contributed an average of \$800 per month to the Foundation.

These pennies have really added up over the years. Every penny you donate is tax-deductible, and it assists our colleagues who apply for the Foundation Grants, which ultimately impact our students. All District 203 teachers are eligible to apply for grants. Last year the Foundation was able to fund over \$34,000 in grants to teachers; \$21,000 in Trustee Awards - \$1,000 to each building for needs identified by the principal; and over \$15,000 in special funding that include Kid Booster Anonymous Grants!
